# SETTING HIGH STANDARDS

**SFI'S STANDARDS** provide an important solution to the long-term sustainability of our forests. With more than 350 million acres/140 million hectares certified and tens of millions more positively influenced through fiber sourcing, SFI has the scale and growth trajectory to ensure positive, forest-based outcomes in the marketplace.

The SFI label provides a tool that allows producers to educate the market and consumers to make responsible purchasing decisions.

SFI sourcing solutions, from certification through to the SFI label, provide choices that help support a circular economy, green building, and contribute to a sustainable future.



**SFI IS CLOSELY CONNECTED TO THE COMMUNITIES WHERE WE OPERATE.** This informs SFI's work and helps SFI engage collaboratively on issues such as logger training, green career pathways, and Indigenous relations.

Thirty-four SFI Implementation Committees, that engage at the state, provincial or regional level, respond to local needs and issues and help deliver SFI's sustainability solutions across the U.S. and Canada. SFI's work aligns closely with Indigenous Peoples through shared values around the benefits of sustainably managed forests. Through networks and partnerships, we work across diverse communities, from urban to rural, to advance awareness of the social and health benefits of sustainable forests.

The SFI Community Grants Program promotes and supports collaboration with the SFI network to help drive community focused solutions.





**SFI'S CONSERVATION WORK** provides leadership, expertise and resources in order to measure and scale the conservation outcomes on forestlands influenced by the SFI standards.

SFI's conservation approach helps provide solutions to sustainability challenges such as species at risk, migratory bird decline, forest health, and climate change. The SFI Conservation Grants Program and Conservation Impact project focus on quantifying the biodiversity maintained and recovered, the water purified, and carbon sequestered on SFI lands, and through sustainable sourcing.

This work is guided by a network of conservation leaders and researchers to ensure credibility and transparency.





#### SFI'S ENVIRONMENTAL EDUCATION PROGRAM, PROJECT LEARNING TREE

educates teachers, community leaders, and youth about forests and the environment. PLT takes students outdoors to learn and connects youth to nature in urban, suburban, and rural settings. With PLT's focus on teaching kids how to think, not what to think, SFI is helping prepare the next generation of leaders to tackle global sustainability challenges like climate change.

PLT Canada focuses on career development and mentorship, and has placed more than 7,000 young adults in Green Jobs in Canada since 2018.

SFI also provides professional development and training for the forest and green building sectors.

## WHY CHOOSE SFI?

SCALE: Over 350 million acres/140 million hectares in the U.S. and Canada are certified to the SFI Forest Management Standard. Tens of millions more are impacted by Fiber Sourcing – a proactive approach that rewards good forestry practices on non-certified lands.



LOW RISK: SFI's standards are specific to the U.S. and Canada where forests are considered low risk for deforestation and activities like illegal logging. This means that our work, and the companies that support it, can focus on elevating the many benefits that come from forests



**RESEARCH:** The SFI standards require forest research making forests certified to SFI a living laboratory for conservation related research.



Since 1995, SFI-certified companies have directly invested \$2 billion in forest research. In 2022, 80% of these investments were allocated to conservationrelated objectives.

**TRAINING:** SFI has 35 grassroots Implementation Committees made up of diverse stakeholders that support local communities and provide support and training of resource and harvesting professionals

#### THREE CERTIFICATION STANDARDS

Choosing certified sustainable forest products is a great way to protect species, combat climate change, reduce plastic pollution, and protect water supplies. Look for the SFI logo when purchasing wood, paper, or packaging products.

SFI standards have become the fastest growing, highly trusted solution that can support a growing need for products from the forest, as the drive to reduce carbon pollution and waste intensifies. We are working to shape markets today and ensure that properly managed forests will continue to play a crucial role in keeping the planet healthy.


The SFI Forest Management Standard is the largest single certification standard in the world. Among its requirements are measures to protect water quality, biodiversity, wildlife habitat, species at risk, and forests with exceptional conservation value.

The SFI Fiber Sourcing Standard is designed for manufacturers that don't own forestland. It distinguishes SFI from all other forest certification programs in that it governs how SFI-certified organizations procure fiber from non-certified forestland in a responsible way.

The SFI Chain-of-Custody Standard is an accounting system that tracks forest fiber content through production and manufacturing to the end product. This standard also has measures to avoid controversial sources in the supply chain.

#### **PROVIDING SUPPLY CHAIN ASSURANCES**

SFI is the leader in providing supply chain assurances. There are more than 350 million acres/140 million hectares of forestland in the U.S. and Canada certified to the SFI Forest Management Standard. And we are still growing.




#### SFI'S FOOTRPINT

In total, SFI certified forestlands in the U.S. and Canada store approximately 250,000 million metric tons (MMT) of carbon dioxide equivalents ( $\rm CO_2e$ ) – an amount roughly equivalent to the total emissions of all the world's gas-powered cars over a period of 38 years. This includes carbon stored in above ground forest biomass (trees, shrubs) and in the underlying soils.



This research was done in a collaboration between the National Council for Air and Stream Improvement (NCASI) and SFI, using published data from USDA and McMaster University.

#### **SFI IMPLEMENTATION COMMITTEES**

At the heart of the SFI community are SFI Implementation Committees (SICs). There are 35 SICs across the United States and Canada, with close to 1,000 volunteers. Their active presence on the ground is resulting in significant contributions to individual communities through activities such as training loggers and other resource professionals and sponsoring outreach to landowners on responsible forest management. This impressive grassroots network is unique to the SFI Program.

SFI-certified organizations are certified by an accredited certification body to be in conformance with the SFI standard. All SFI-certified organizations owning or operating primary forest product facilities, owning or managing forestland, or procuring fiber within the state or province are expected to participate in their local SFI Implementation Committee. This approach is unique to the SFI Program — no other forest certification program in the world has this level of grassroots support to promote responsible forestry,

#### **COMMITTEE PRIORITIES**

SFI Implementation Committees are an integral part of the SFI Program and typically are the most visible element of the Program at a local level. They play a key role in increasing SFI Program recognition, recruiting SFI-certified organizations, and protecting the integrity of the Program by monitoring for improper logo usage or claims. SFI Implementation Committees offer a forum to provide information or answer questions about local forestry operations and provide a public process for responding to concerns about forestry practices that appear to be inconsistent with the SFI Standards and Rules. Most Implementation Committees also administer programming that helps local SFI-certified organizations collaborate on achieving specific SFI Standard requirements. While the priorities of each SIC are unique, these programs can include:

- Training, education and outreach to loggers, foresters, landowners, youth, and the public
- Supporting forestry research
- Raising awareness of climate change, wildfire, threatened and endangered species, and forests with exceptional conservation value
- Engaging with community organizations such as Habitat for Humanity, Make a Wish Foundation, or others

#### INDEPENDENCE AND AUTONOMY

While SFI Implementation Committees are provided guidance, they have a significant amount of autonomy in how they are structured and what priorities they pursue. The Committees have the freedom to develop projects, programs and activities, and make decisions about the best way to accomplish these priorities.

The Committees secure their own funding, establish their own governance and leadership structures, design and implement locally-developed projects, and determine the best way to achieve the results they desire.

SFI Inc. does not provide direct funding to the SFI Implementation Committees. Many Committees, including the Pennsylvania SFI Implementation Committee, are primarily funded by local SFI-certified Organizations and other members of the forest products industry who have a strong desire to help promote the wise use of forest resources and protect their economic, social, and ecological values for today and generations to come.

#### PENNSYLVANIA SFI IMPLEMENTATION COMMITTEE

Our purpose is to promote wise forest stewardship, enabling Pennsylvania communities to thrive through a successful forest products industry. We work hard to support business operations by training and developing the logger workforce, educating the public about the value of working forests, promoting SFI forest certification, and assisting with regulatory issues.

Committee membership is a blend of SFI-certified organizations and other local supporting companies and organizations. This involves a diverse group of local forest stakeholders, including private forest landowners, professional timber harvesters, forestry professionals, local government officials, academics, scientists, and conservationists. The diversity of members ensures representation of many different perspectives, fresh ideas, and the capacity to implement the work members deem important to their goals and objectives. Our alliance of deeply committed professionals from across the forestry community builds partnerships with many other conservation organizations who depend on the forest industry to advance their own missions. These relationships allow us to serve with great impact.

Our work does not focus exclusively on SFI certified lands, but reaches beyond by including efforts to expand sustainable forestry practices on uncertified lands through timber harvester education and private forest landowner outreach. To date, the SIC has distributed tens of thousands of outreach materials to Pennsylvania's private forest landowners, and more than 7,000 individuals have participated in the PA SFI Professional Timber Harvester Training Program. SFI-certified organizations are required to prioritize the use of SFI Qualified Logging Professionals. This includes all 2.2 million acres of state forest lands under the Pennsylvania Bureau of Forestry. Many other forest landowners and forest product companies have adopted similar requirements. Our training participants work across Pennsylvania and are implementing the new things they learn through our training program on a daily basis.

#### TRAINING AND EDUCATION











THE PA SFI PROFESSIONAL TIMBER HARVESTER TRAINING PROGRAM is designed to educate Pennsylvania's logging workforce and give them the tools they need to operate safely and efficiently, in accordance with all applicable rules and regulations, and to sustainably manage our forests for generations to come. The Pennsylvania SIC provides high quality educational opportunities through our training program by partnering with experts in related fields.



#### PROVIDING A UNIQUE FORUM

The PA SIC itself provides a unique and valuable forum that allows different segments of Pennsylvania's forest sector to come together and gain a better understanding of each other's issues and perspectives. Our Committee of volunteers brings together sawmills, pulp mills, forest landowners, loggers, managers of private forest land,

the Bureau of Forestry, the Game Commission, Conservation Districts, Penn State professors and extension personnel, industry associations, and others. The PA SIC demonstrates that we are all linked together and each link is important to the sustainability of our forests as well as the industries and people that depend on them.



#### **GOVERNMENT SUPPORTED**

The Pennsylvania General Assembly was the first state legislative body to recognize and endorse SFI through a formal resolution in 1996 (SR 160 and HR 480). In 2015, the General Assembly again recognized the PA SIC with formal resolutions (SR 144 and HR 375) in

celebration of our 20th anniversary (1995-2015) and for our involvement in setting a Guinness World Record for tree planting. The resolutions designated June 5, 2015 as "PA Sustainable Forestry Initiative Day" in Pennsylvania.



#### EXEMPLIFYING THE "I IN INITIATIVE"

The PA SIC has twice been recognized with the SFI Implementation Committee Achievement Award -- in 2001 and 2015. The award recognizes SICs for outstanding work in implementing the SFI program, making a difference on-the-ground advancing sustainable forestry and promoting the benefits of forests and forest products certified to the SFI standard.



#### **RECORD BREAKING**

In order to bring global recognition to the importance of our forests while also helping to ensure their future, the PA SIC engaged in a successful 2015 attempt to set the Guinness World Record for the most trees planted in one hour simultaneously by small groups. Two teams of

volunteer planters in Pennsylvania joined 27 other teams across the United States and Canada and planted a combined 202,935 trees during the single hour event (7,248 trees planted in Pennsylvania alone). The effort was nearly 5 times what the attempt needed to exceed in order to obtain the record.



#### TRAINING AND EDUCATION

The PA SIC provides the only statewide logger training program with established curriculum requirements that include continuing education and verifiable recordkeeping in Pennsylvania. Since 1995, more than 7,000 individuals have participated in our PA

SFI Professional Timber Harvester Training Program. Strong partnerships with Penn State, Extension educators, wildlife specialists, staff from numerous County Conservation Districts, and other experts from the natural resources, logging, and finance industries help supply high quality training on critical topics such as chainsaw felling safety, best management practices, habitat management, log quality optimization, sustainable forestry, business management, and many more.



#### **LANDOWNER OUTREACH**

In our first two decades, the PA SIC distributed more than 26,000 information and resource packets about sustainable forestry to forest landowners across Pennsylvania. With web access, these materials have been updated, made more comprehensive, and are now

more accessible to a wider audience. As a result, the PA SIC website (<u>sfiofpa.org</u>) has become a central clearinghouse of information for forest landowners.



#### **BUILDING THE FUTURE**

The PA SIC supports the next generation of Pennsylvania's forest products industry workforce by partnering with High School vo-tech programs to offer their students the core component of the PA SFI Professional Timber Harvester Training Program. It is our hope that exposure to this excellent training will

encourage young adults to consider a career in the forest products industry.



#### **COMMUNITY FOCUS**

The PA SIC sponsors a number of worthy organizations and events to promote sustainable forestry. These include the Pennsylvania 4-H Forestry Program, the annual Walk in Penn's Woods event, the Log A Load for Kids charity that supports Children's Miracle Network-

affiliated hospitals, The Penn State Center for Private Forests' biennial landowner conferences, and the Hardwoods Development Council's WoodMobile.



#### SPREADING THE WORD

Forest Leaves, a quarterly newsletter providing timely tips and stories about caring for one's woods, is one of the most widely distributed forestry publications in the state. This resource for landowners is a joint venture among the PA SIC. Penn State Extension, PA DCNR Bureau of Forestry, the Pennsylvania Tree Farm committee, the Pennsylvania Forestry Association,

and the Center for Private Forests. All partners contribute funds, content, and distribution support for this publication. The PA SIC also publishes a biannual newsletter and contributes content to a number of other publications such as Pennsylvania Forests magazines.



#### **CULTIVATING CREDIBILITY**

The PA SIC responds to allegations of practices that appear inconsistent with the SFI Standard principles and objectives. The Inconsistent Practices Program is a resource open to anyone and provides a venue for reporting and addressing these concerns. The program was established to foster a
