**Implementation Committee Enters New Cooperative Agreement with  
the Pennsylvania Game Commission**

On July 25<sup>th</sup> the Pennsylvania SFI Implementation Committee (PA SIC) and the Pennsylvania Game Commission (PGC) entered into a three-year cooperative agreement that provides support and recognition to the Implementation Committee's efforts that bolster the PGC's mission and programming.

The PGC partnership recognizes the valuable education and outreach the PA SIC provides professional loggers that are integral to completing forest habitat management work on State Game Lands. The Commission also recognizes the PA SIC's sustainable forestry outreach to Pennsylvania citizens that utilize PGC forest lands or who own private forestlands that host critical wildlife habitat.

Through the agreement, the PGC will make PGC facilities and State Game Land areas suitable for training or organization meetings available to PA SFI and will provide funding support to conduct training and outreach.

## New Best Management Practices for Timber Harvest Operations

An important publication received its final approval at the end of July and was added to the official document library of the Pennsylvania Department of Environmental Protection (DEP). Pennsylvania's *Best Management Practices for Timber Harvest Operations* (3850-BK-DEP5577), dated July 2023 represents the culmination of a dedicated effort among partners to ensure that relevant, easy-to-use information is made available to timber harvesters across the Commonwealth. This publication takes the place of the former *Timber Harvest Operations Field Guide for Waterways, Wetlands and Erosion Control* (3930-BK-DEP4016), which DEP declared to be obsolete and took out of circulation in 2017 as a result of earlier updates to Chapter 102 and Chapter 105 regulations related to earth disturbance and waterway management.

With DEP announcing they had no plans to update the publication, industry members and partners immediately stepped forward to spearhead efforts towards developing a revised document. A working group was formed, but their first task was to revise and reinstate the widely used Erosion & Sediment Control Plan Template for Timber Harvest Operations (3800-FM-BCW0539), which DEP also discontinued in 2017. That undertaking was successfully completed in fall 2018.

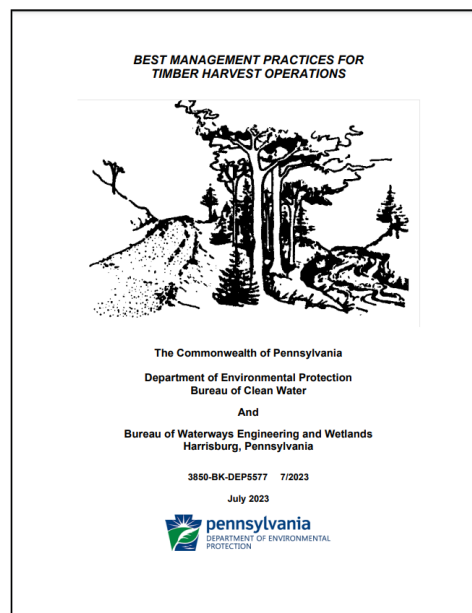
Efforts to revise the field guide began in 2019 when Pennsylvania SFI Implementation Committee Program Manager Chuck Coup led a working group of individuals to draft and submit the proposed updated document, combining knowledge of timber harvesting best management practices with a review of the revised DEP regulations. The working group engaged with DEP for nearly four years to seek final approval and publication.

The final document neatly organizes relevant state and federal regulations, planning considerations that include soil, water, and site layout recommendations, and Best Management Practice (BMP) implementation and maintenance guidelines. The publication also includes embedded QR codes that quickly connect users to additional resources and guidance via a smart phone or tablet.

Timber harvesting is a vital industry in Pennsylvania, contributing to both economic growth and forest management. However, ensuring that these operations are conducted in an environmentally responsible manner is of paramount importance. The new manual is a valuable resource for landowners, loggers, and other stakeholders involved in timber harvesting activities. It provides a common source for interpreting environmental regulations as they apply specifically to timber harvesting operations. It serves as a helpful reference not only for foresters and timber harvesters, but also for Conservation District personnel and other regulatory staff to find an agreed-upon interpretation of methods in the field rather than attempting to interpret regulatory language from its source.

The PA SIC encourages all stakeholders involved in timber harvesting to familiarize themselves with the manual's recommendations and integrate them into their operations. The publication (Document# 3850-BK-DEP5577, dated July 2023) is accessible from the main page of DEP's eLibrary ([www.depgreenport.state.pa.us/elibrary/](http://www.depgreenport.state.pa.us/elibrary/)) by going to "Publications" and "CLEAN WATER." ### Forests with Exceptional Conservation Value

Forests are not only beautiful and ecologically rich landscapes, but they also play a crucial role in supporting our planet's biodiversity, mitigating climate change, and providing a wide range of ecosystem services. Among our forests, those with exceptional conservation value stand out for their unique characteristics and contributions. It's important to recognize the significance of maintaining and protecting these special areas.

Forests with Exceptional Conservation Value (FECV) are areas that possess rare, threatened, or endangered species, unique ecosystems, or provide critical habitat for wildlife. These forests often have high levels of biodiversity and contain species that are not found in other areas. They can be home to endemic species that are found nowhere else in the world, making them crucial for global biodiversity conservation.

It's important to understand that forest management can help FECV thrive. In fact,

active management is necessary for the survival of some species. However, it is up to landowners, foresters, and loggers to take the necessary steps to identify and conserve these species and communities.

Those involved in forest management have a unique opportunity and responsibility to contribute to the protection of FECV. By understanding their significance and taking proactive steps towards their conservation, you can play a pivotal role in safeguarding these remarkable ecosystems for generations to come.

The PA SIC encourages everyone conducting timber harvesting and vegetation management activities to utilize the Pennsylvania Natural Diversity Inventory (PNDI) Environmental Review Tool to screen for potential impacts to imperiled and critically imperiled species and other rare and significant ecological features in Pennsylvania. ### OTHER CONTINUING EDUCATION TRAINING

Additional training opportunities are available through numerous organizations across Pennsylvania and adjoining states. To submit a Non-PA SFI training course please fill out a copy of the Non-PA SFI Course Credit Form (available on our website under "Forms" section or by contacting the PA SIC office) and send it to the PA SIC office with all necessary paperwork and a check for \$20 made payable to the "PA SFI Implementation Committee" for administrative costs. ### SELF-PACED/ASYNCHRONOUS ONLINE LOGGER TRAINING COURSES

- Self-paced/Asynchronous online courses give training participants the flexibility to complete training when it is most convenient for them. The user is in control of what they learn, when they learn it, and where they learn it.
- Several self-directed training courses for loggers have been approved for continuing education (CE) credit in the Pennsylvania SFI Professional Timber Harvester Training Program.
- These online continuing education classes require a high-speed internet connection, and a computer or smart phone with functioning speakers.

### COURSE DESCRIPTIONS

#### CORE TRAINING:

Required to be recognized as an SFI Qualified Logging Professional. All 3 core training courses must be completed (in any order) within a 2 year period. Professional Timber Harvesting Essentials and/or Game of Logging Level 1 can be taken for CE Credit, IF you have not already completed the training in the last 5 years.

- **Professional Timber Harvesting Essentials (8 hours)** - Covers general safety considerations, chainsaw safety, logging equipment safety (harvesters, loaders, skidders, etc.), trucking safety and Occupational Safety and Health Administration (OSHA) Standards that apply to timber harvesting and related activities. Also covers pertinent aspects of Pennsylvania's Clean Streams laws and other water resource protection regulations, Best Management Practices (BMPs), hazardous material control, and logging aesthetics.
- **Game of Logging - Level 1 (8 hours)** - Focuses on introducing the participant to the "open face" felling technique and the development of skills to safely use it. Topics covered include personal protective equipment, chainsaw safety features, chainsaw reactive forces, bore cutting, pre-planning the fell, and understanding hinge wood strength. Participants need safety equipment (hard hat, chaps, eye protection, ear protection, and sturdy boots), water, lunch, and should be prepared to spend the day outside (rain or shine). Participants are not required to provide their own chainsaw.
- **First Aid & CPR (4 hours)** - Because timber harvesting is a hazardous occupation, OSHA regulations require that everyone who works in the woods maintain current First Aid & CPR training from a provider who can issue a certificate or a card as documentation of hands-on training (i.e., no online certifications will be accepted). Individuals do not need to complete this training through the PA SFI Professional Timber Harvester Training Program; however, they must provide proof of First Aid & CPR certification to receive their initial training card (we cannot accept the MSHA 5000-23 form as satisfaction of this requirement). Course duration varies by instructor. **DOES NOT COUNT FOR CE CREDIT.**

#### CONTINUING EDUCATION (CE):

One (1) year of CE credit is given for each four (4) hours of CE training completed. CE credits can only extend your validation date a maximum of three (3) years from the current calendar year. CE credit will not be awarded for taking the same class more than once in a five (5) year period.

- **Advanced Logger Rescue (8 hours)** - Geared to prepare firefighters, EMS personnel, foresters, and loggers in taking action to reduce severity of injury and increase the chance of survival during a logging accident, this program teaches all participants how to handle an "in woods" rescue from the time a person has not arrived home until they are transported to a Level-1 Trauma Center
- **Erosion Control in Our Forests (8 hours)** - This workshop combines indoor and outdoor instruction time to discuss Pennsylvania's environmental regulatory requirements (chapters 93, 102, & 105 of PA Code). It discusses planning before the harvest, stream crossings, best management practices, reading E&S plans, and other considerations during and after the timber harvest.
- **Game of Logging (8 hours, each Level)** - These courses cover chainsaw safety and safe/efficient harvesting techniques. They MUST be taken in order. Level 1 (see description under Core Training section). Level 2 focuses on saw maintenance, chain sharpening techniques, releasing spring poles safely, and directional tree felling. Level 3 focuses on handling difficult trees. Topics covered include limbing, wedging techniques and hinge placement. Level 4 is a review of previous levels with participants practicing skills at working speed. This training is conducted in the field.
- **Intro to Reptiles and Amphibians & their habitats within PA (4 hours)** - This course will provide a better understanding of the "herp" species that are most frequently encountered during natural resource extraction in our state's forests. Instructors will review habitat requirements in terms of breeding activities, migratory patterns, and overall natural history. Live herp specimens and models will be used to sharpen field identification skills and examine each species' unique adaptations. Participants will be introduced to the northeast region's habitat management guidelines endorsed by PARC (Partners in Amphibian and Reptile Conservation) which can be utilized by private landowners, land managers and industry leaders to minimize threats to local herpetile populations.
- **Native Plants of Pennsylvania (4 hours)** - Native plants have evolved naturally in a region over many years, rather than being introduced from another area. This course provides an introduction to native plants for foresters and logging professionals. It features common native plants in Pennsylvania and surrounding regions and includes in-field instruction.
- **Outdoor Survival Skills for Timber Harvesters (4 hours)** - This course covers various aspects of dealing with outdoor survival situations. A major emphasis is placed on being prepared for unexpected emergencies and preventing hypothermia. Items to have with you, compass and map skills, and shelter/fire building techniques are among the many aspects discussed in detail. Hands on experience is provided to all participants in compass/map and fire building exercises.
- **Wildlife – Young Forest Initiative (4 hours)** - Developed through a cooperative program with the Wildlife Management Institute, this course discusses the importance of creating early successional forest conditions for the benefit of multiple wildlife species. Participants will learn and be given tools to identify and create habitat systems for the American Woodcock, Golden Winged Warbler, and other young forest dependent wildlife species important to forest landowners.
- **The Relationship Between Lumber, Tree, and Log Grades (8 hours)** - This course will introduce basic knowledge about hardwood lumber grades, tree grades, and log grades. It will explain how the different grades are established and will provide an understanding of how the tree, lumber, and log grades relate to one another.
