PROJECT SCREENING

The following questionnaire will aid in determining compliance requirements with the Department of Environmental Protection's Chapter 102 Erosion and Sediment Pollution Control Program, Chapter 92 National Pollutant Discharge Elimination System (NPDES) Program and the Chapter 105 Dam Safety and Waterway Management Program.

- (1) Yes No Does this project disturb more than 5,000 square feet or occur in a special protection watershed? **If yes**, a written Erosion & Sedimentation pollution control plan is required to be on site and implemented. Approval through the District is not required, unless requested through a local entity. The District or DEP may request to see the E&S plan in the event of a complaint, pollution event, or failure to implement and maintain effective E&S BMPs. The plan may be subject to submittal for approval by the District/DEP if there are issues with the site. Contact the District. **If no**, then a written plan is not necessary, but erosion and sediment control best management practices are still required to minimize the potential for accelerated erosion and sedimentation.
- (2) Yes No Does this project involve timber harvesting or road maintenance activity involving 25 acres (10 hectares) or more of earth disturbance? **If yes**, an Erosion and Sedimentation Control Permit is required to be submitted for approval to the District. Before any earth disturbance activity can occur the plan must be approved. A copy of the approved stamped, signed, and dated plan must be kept on site. See #3 below.
- (3) Yes No Does this project require an E&S Control Permit (#2 above) and occur in a special protection watershed? **If yes**, requirements under #1 and 2 apply and project must utilize nondischarge alternatives and/or antidegradation best available combination of technologies (ABACT). Contact the District or DEP for assistance.
- (4) Yes No Does this project involve land clearing/development (i.e. forest conversion) that disturbs 1 acre or more? **If yes**, then a National Pollution Discharge Elimination System (NPDES) permit is required to be submitted for approval to the District. Before any earth disturbance activity can occur the plan must be approved. A copy of the approved stamped, signed, and dated plan must be kept on site. Contact the District or DEP for assistance.
- (5) Yes No Does this project involve the temporary and/or permanent fill or excavation of wetlands? **If yes**, please contact the District or DEP for assistance.
- (6) Yes No Does this project change, expand or diminish the course, current or cross section of a water source, floodway or waterbody with an upstream drainage area greater than 100 acres? **If yes**, the project is regulated by the DEP, Chapter 105 regulations, please contact the District or DEP for assistance. **If no**, this project may qualify for a permit waiver. Contact the District or DEP for confirmation.
- (7) Yes No Is this project being done by a township, county, government entity, or public utility and is in the 100 year flood plain shown on a FEMA map? If yes, then the project is regulated by DEP under Chapter 106 of the Floodplain Management Regulation. Please contact the District or DEP for assistance.
