Project Learning Tree and Sustainable Forestry Initiative Join Forces to Expand Youth Environmental Education Programs

The Sustainable Forestry Initiative Inc. (SFI) and the American Forest Foundation (AFF) announced in July that SFI has become the new home of Project Learning Tree (PLT). PLT is an award-winning environmental education program that uses trees and forests as windows on the world to increase youth understanding of the environment and actions they can take to conserve it. PLT's integration into SFI provides an opportunity for the program to expand its reach and impact. And SFI's role as a sustainability leader will be bolstered by PLT's expertise in education, an increasing focus in SFI's community engagement work. PLT was previously housed at the American Forest Foundation.



"SFI has enthusiastically supported Project Learning Tree for years. Formally making PLT part of the SFI Program offers an exciting opportunity to strengthen SFI's growing youth education efforts and to build on PLT's enormous success. We begin this relationship from a position of strength given SFI's role as a leading sustainability organization focused on responsible forestry, conservation and community engagement" said Kathy Abusow, President and CEO of SFI Inc. "We have big plans for the future and are committed to continuing PLT's work as a high-quality education program. Ultimately, we would like to be able to say that every teacher across North America and beyond recognizes Project Learning Tree as an invaluable resource for professional development, environmental education curriculum, and taking children outdoors to learn."

"For more than four decades, Project Learning Tree has taught countless students how to think, without telling them what to think. It is the unbiased education that educators demand," said Tom Martin, President and CEO of the American Forest Foundation. "The AFF Board approved the transfer of PLT as well as funding to help ensure the program is maintained for the next five years. We believe this will enable SFI to focus its energy on mechanisms to strengthen and expand the reach of PLT."

PLT's network includes state government agencies, forestry associations, non-profits, colleges and universities that deliver PLT programming across the U.S., British Columbia, Mexico, Japan, Brazil, and Uruguay. SFI's youth network is made up of more than 20 organizations including Boy Scouts of America, Scouts Canada, Earth Rangers, Forest Ontario's Forestry Connects Program, Envirothon, 4-H, the State University of New York's Center for Native Peoples and the Environment, and other Indigenous youth programs. This considerable network will enhance PLT's relevance as a critical element of youth education in support of future forests.

"SFI is a recognized leader in sustainability and will introduce PLT across Canada and beyond to reach even more educators and youth about the forests we share," said Gail Wallin, Co-Chair of the Canadian Council on Invasive Species and SFI Board member in the environmental chamber. "I believe both organizations will benefit through this new relationship given the common interests, expertise, and passion for the environment and education."

Sustainable Forestry Initiative® (SFI®) Program

SFI Inc. (www.sfiprogram.org) is an independent non-profit organization that is solely responsible for the internationally recognized Sustainable Forestry Initiative (SFI) Program. The program promotes sustainable forest management, improved forestry practices, and responsible purchasing of forest products through its forest certification standard.

SFI is the largest single forest certification standard in the world, with more than 250 million acres certified. At the heart of the SFI Program are SFI Implementation Committees (SICs). The Pennsylvania SIC is one of 34 spread across North America that responds to local needs and issues through the SFI Program at the local level. This grassroots network is unique to the SFI Program.

Since 1995, the Pennsylvania SIC's active presence on the ground has resulted in significant contributions to individual communities through activities such as training loggers and sponsoring outreach to landowners on responsible forest management.

SFI's community engagement work includes a long commitment to youth education including previous funding for PLT through SFI Community Partnerships Grants. SFI Implementation Committees also collaborate with PLT to teach kids about trees, forests, and the natural world through hands-on activities that are STEM-focused and inquiry-based.

"Given the history of SFI's coordination with Project Learning Tree on a national scale and the shared commitment to educating youth, bringing PLT into the SFI program is a natural progression of the relationship because both organizations will be strengthened. As a member of the SFI Board of Directors, and a State Forester, I am excited about how this partnership will support educators and develop future conservation and forest leaders," said Bettina Ring, State Forester with the Virginia Department of Forestry and an SFI Board member in the social chamber.

ALIFT Program Helps Loggers

When a logger is injured on the job and unable to work they typically stop receiving pay. Most, but not all loggers, have insurance that can provide for them if they do have an injury; however, claims often take time to be processed. During that time families can struggle to pay for everyday expenses like groceries and electric bills. "

The idea with ALIFT was to get them money within a day or two of the accident" explains Jim Soltis of Tunkhannock. Soltis is a certified forester and founder of ALIFT (Assisting Loggers Immediately Fund Trust), a new nonprofit organization that has helped those impacted by logging industry accidents since 2015. The fund is not designed to replace or even supplement insurance coverage. It is simply a way to get immediate funds to the families – It's there to give the families "A LIFT!" Last year alone, ALIFT helped nine logging accident victims and their families located across Pennsylvania and they hope to grow the program to assist many more in the future.



ALIFT is primarily funded through direct contributions and fundraisers. Paul served as a long-time member of the Pennsylvania SIC where his leadership, mission support, and faithful attendance lead to contributions far too numerous to even attempt to list.



Paul was the Executive Director of the Pennsylvania Forest Products Association, where he served tirelessly as a lobbyist and advocate for the Commonwealth's forest products industry. Prior to that, Paul was the Executive Director of the Hardwoods Development Council (1998-2002). Paul's outstanding leadership was recognized throughout the state as well as the nation. In 2015, Paul was the recipient of the prestigious Joseph T. Rothrock Conservationist of the Year Award. In addition to his significant contributions on law and government policy that impacted the industry, he also was the initiator of the PA WoodMobile program while he worked for the Council, and remained a strong supporter of the WoodMobile throughout the years.

The SIC and the Forest Products Industry in Pennsylvania are indebted to Paul for his many contributions and leadership. Our thoughts and prayers continue for his wife, Kathleen; son, Sean and his mother and father, Barbara and Frank Lyskava of Murrysville, PA.

American Loggers Council Board Approves Proposal to Strengthen ALC Master Logger Certification Program

The American Loggers Council voted to move forward with a proposal submitted by the Professional Logging Contractors of Maine and the Trust to Conserve



Northeast Forests that would help to revitalize and promote the American Loggers Council Master Logger Certification® program.

Since the program was first adopted in 2000 during the ALC's Annual meeting held in Beaumont, Texas, 18 states have approved templates for implementation of the program, with several currently implementing the program. The ALC's national Master Logger Certification® program template provides guidance for the seven areas of responsibility that meet the performance standards of the program, but allows each state participant to tailor their program based on existing state regulations and forest practices acts.

The ALC Master Logger Certification® program is a true third-party certification system that verifies on the ground harvesting and business practices that can meet chain of custody requirements found in many of today's forest certification systems. Oversight of the program is through the ALC Master Logger Certification committee with individual states and regions implementing the program tailored to their needs.

Participation in the program remains voluntary, and states will be required to determine just how they implement the program, and what costs (if any) might be incurred.

ALC's Master Logger Committee Chairman Crad Jaynes commented, "The actions taken by the ALC board to support the proposal shows continued support for the principles the ALC Master Logger Certification program was founded on. This energized marketing effort hopefully will improve the recognition of ALC Third Party Certified Master Loggers to the public and demonstrate sustainable timber harvesting is being practiced thus contributing to meeting chain of custody standards in forest certification systems. ALC's Master Logger Certification program is 'logger owned and logger run.' The ALC Master Logger Certification Committee looks forward to working in this process to have 'true' third party certified loggers further recognized for their work on the ground and in their business."

The Pennsylvania SFI Implementation Committee (PA SIC) offered a certified master logger program in the early 2000s with rigorous requirements. Only four individuals ever attained this level of recognition. Currently, the PA SIC operates the SFI Professional Timber Harvester Training Program which provides a credential verifying an individual has completed mandatory training requirements. However, the Pennsylvania SIC no longer performs on the ground auditing of participant practices and therefore does not provide third-party certification of individuals or companies. To date, the Pennsylvania SFI Implementation Committee has not been in contact with anyone at the American Loggers Council.

2017 COURSE DESCRIPTIONS

CORE TRAINING:

Required to receive a PA SFI® Professional Timber Harvester Training Card. All 3 requirements must be completed within 2 years.

- **Professional Timber Harvesting Essentials (8 hours)** - Covers general safety considerations, chainsaw safety, logging equipment safety (harvesters, loaders, skidders, etc.), trucking safety and Occupational Safety and Health Administration (OSHA) Standards that apply to timber harvesting and related activities. Also covers pertinent aspects of Pennsylvania's Clean Streams laws and other water resource protection regulations, Best Management Practices (BMPs), hazardous material control, and logging aesthetics. DOES NOT COUNT FOR CONTINUING EDUCATION CREDIT.
- **Game of Logging – Level 1 (8 hours)** - Focuses on introducing the participant to the "open face" felling technique and the development of skills to safely use it. Topics covered include personal protective equipment, chainsaw safety features, chainsaw reactive forces, bore cutting, pre-planning the fell, and understanding hinge wood strength. Participants need safety equipment (hard hat, chaps, eye protection, ear protection, and sturdy boots), water, lunch, and should be prepared to spend the day outside (rain or shine). Participants are not required to provide their own chainsaw. If you have not taken Game of Logging – Level 1 within the last five (5) years, you can attend GOL-1 for continuing education credit.
- **First Aid & CPR (4 hours)** - Because timber harvesting is a hazardous occupation, OSHA regulations require that everyone who works in the woods maintain current First Aid & CPR training from a provider who can issue a certificate or a card as documentation of hands on training (i.e. no online certifications will be accepted). Individuals do not need to complete this training through the PA SFI Professional Timber Harvester Training Program; however, they must provide proof of First Aid & CPR certification to receive their initial training card (we cannot accept the MSHA 5000-23 form as satisfaction of this requirement). DOES NOT COUNT FOR CE CREDIT.

CONTINUING EDUCATION (CE):

One (1) year of CE credit is given for each four (4) hours of CE training completed. CE credits can only extend your card date a maximum of three (3) years from the current calendar year. CE credit will not be awarded for taking the same class more than once in a five (5) year period.

- **Advanced Logger Rescue (8 hours)** - Geared to prepare firefighters, EMS personnel, foresters, and loggers in taking action to reduce severity of injury and increase the chance of survival during a logging accident, this program teaches all participants how to handle an "in woods" rescue from the time a person has not arrived home until they are transported to a Level-1 Trauma Center.
- **Business Management for Timber Harvesters (8 hours)** - Profitability of a timber harvesting businesses is key to long term viability and implementing sustainable management practices. Participants are introduced to business plans, documents used for financial analysis, key people, sources of assistance, employee management, and other components of running a successful business. This is a great class for new loggers starting their own business or established loggers looking for a refresher.
- **ESM Dirt and Gravel Roads (8 hours)** - A comprehensive one-day course focusing on innovative and effective practices to reduce maintenance costs and sediment pollution from unpaved roads. This course will highlight new dirt, gravel, and Low-volume road maintenance stream crossing policy and assessment tools for crossings.
- **Estimating Standing Timber (8 hours)** - This course helps to avoid those errors in volume estimates that can spell disaster when the harvest is conducted. The tools and correct methods for measuring and estimating volume (how many board feet or tons of wood) trees contain prior to harvest is thoroughly covered. Instruction is also given for basic sampling techniques. This training involves both classroom and field exercises.
- **Game of Logging (8 hours, each Level)** - These courses cover chainsaw safety and safe/efficient harvesting techniques. They MUST be taken in order. **Level 1** (see description under Core Training section). **Level 2** focuses on saw maintenance, chain sharpening techniques, releasing spring poles safely, and directional tree felling. **Level 3** focuses on handling difficult trees. Topics covered include limbing, wedging techniques and hinge placement. **Level 4** focuses on ways to maximize a harvest plan for safety and productivity. Felling is practiced at working speed using all the techniques from the previous levels. **Danger Tree Workshop** emphasizes important elements of the Game of Logging training that should be used when evaluating and felling danger trees.
- **Hydraulic Systems Safety & Maintenance (8 hours)** - This hands-on course will introduce participants to the theory of hydraulic operation, nomenclature and function of associated components, safety practices, general maintenance, and diagnostic troubleshooting of hydraulic systems. It is taught at Penn College of Technology's heavy equipment lab.
- **Outdoor Survival Skills for Timber Harvesters (4 hours)** - This course covers various aspects of dealing with outdoor survival situations. A major emphasis is placed on being prepared for unexpected emergencies and preventing hypothermia. Items to have with you, compass and map skills, and shelter/fire building techniques are among the many aspects discussed in detail. Hands on experience is provided to all participants in compass/map and fire building exercises.
- **PA Wildlife Species of Greatest Conservation Need (4 hours)** - A comprehensive course on Pennsylvania wildlife that are at risk for a variety of reasons. Causes for population declines and restoration efforts for several species will be highlighted. Up-to-date information on the status of state and federal threatened endangered species and potential impacts on timber harvesting will be included.
- **Regenerating Hardwood Forests (8 hours)** - This workshop will focus on the challenges surrounding the successful establishment of desirable forest regeneration. Under many circumstances, establishing desirable regeneration is not easy. This workshop will teach you about competing and invasive plants, deer impact, and proper harvesting methods to successfully establishing desirable forest regeneration.
- **Sustainable Timber Harvesting (8 hours)** - How do you know that a timber harvest is "sustainable?" What are the consequences of high-grading and diameter limit cuts? This course covers the elements of sustainable harvesting practices and how to assess a stand. It focuses on the forest that remains as a result of the harvest.
